## 1.0 Introduction

This program directory is intended for system programmers who are responsible for program installation and maintenance. It contains information about the material and procedures associated with the installation of IBM MQ Managed File Transfer for z/OS. This publication refers to IBM MQ Managed File Transfer for z/OS as MQ Managed File Transfer.

The Program Directory contains the following sections:

- 2.0, “Program Materials” on page 3 identifies the basic program materials and documentation for MQ Managed File Transfer.
- 3.0, “Program Support” on page 5 describes the IBM support available for MQ Managed File Transfer.
- 4.0, “Program and Service Level Information” on page 7 lists the APARs (program level) and PTFs (service level) that have been incorporated into MQ Managed File Transfer.
- 5.0, “Installation Requirements and Considerations” on page 9 identifies the resources and considerations that are required for installing and using MQ Managed File Transfer.
- 6.0, “Installation Instructions” on page 17 provides detailed installation instructions for MQ Managed File Transfer. It also describes the procedures for activating the functions of MQ Managed File Transfer, or refers to appropriate publications.

Before installing MQ Managed File Transfer, read the *CBPDO Memo To Users* and the *CBPDO Memo To Users Extension* that are supplied with this program in softcopy format and this program directory; then keep them for future reference. Section 3.2, “Preventive Service Planning” on page 5 tells you how to find any updates to the information and procedures in this program directory.

MQ Managed File Transfer is supplied in a Custom-Built Product Delivery Offering (CBPDO, 5751-CS3). The program directory that is provided in softcopy format on the CBPDO tape is identical to the hardcopy format if one was included with your order. All service and HOLDDATA for MQ Managed File Transfer are included on the CBPDO tape.

Do not use this program directory if you install MQ Managed File Transfer with a SystemPac or ServerPac. When you use one of those offerings, use the jobs and documentation supplied with the offering. The offering will point you to specific sections of this program directory as needed.

### 1.1 MQ Managed File Transfer Description

MQ Managed File Transfer provides a managed file transfer solution, based on the IBM MQ transport, for moving files between IT systems without the need for programming. This product moves files in a reliable, secure, and auditable manner and enables file transfers to be fully-automated including scheduled and triggered transfers.

MQ Managed File Transfer has two types of release; a Long Term Support Release (LTSR) and a Continuous Delivery (CD) release. ### 3.2 Preventive Service Planning

Before you install MQ Managed File Transfer, make sure that you have reviewed the current Preventive Service Planning (PSP) information. Review the PSP Bucket for General Information, Installation Documentation, and the Cross Product Dependencies sections. For the Recommended Service section, instead of reviewing the PSP Bucket, it is recommended you use the IBM.ProductInstall-RequiredService fix category in SMP/E to ensure you have all the recommended service installed. Use the **FIXCAT(IBM.ProductInstall-RequiredService)** operand on the **APPLY CHECK command**. See 6.1.10, “Perform SMP/E APPLY” on page 22 for a sample APPLY command.

If you obtained MQ Managed File Transfer as part of a CBPDO, HOLDDATA is included.

If the CBPDO for MQ Managed File Transfer is older than two weeks by the time you install the product materials, you can obtain the latest PSP Bucket information by going to the following website:

### 4.2 Service Level Information

No PTFs against this release of MQ Managed File Transfer have been incorporated into the product package.

Frequently check the MQ Managed File Transfer PSP Bucket for HIPER and SPECIAL attention PTFs against all FMIDs that you must install. You can also receive the latest HOLDDATA, then add the **FIXCAT(IBM.PRODUCTINSTALL-REQUIRESERVICE)** operand on your APPLY CHECK command. This will allow you to review the recommended and critical service that should be installed with your FMIDs.



---

## 5.0 Installation Requirements and Considerations

The following sections identify the system requirements for installing and activating MQ Managed File Transfer. The following terminology is used:

- *Driving system*: the system on which SMP/E is executed to install the program.  
The program might have specific operating system or product level requirements for using processes, such as binder or assembly utilities during the installation.
- *Target system*: the system on which the program is configured and run.  
The program might have specific product level requirements, such as needing access to the library of another product for link-edits. These requirements, either mandatory or optional, might directly affect the element during the installation or in its basic or enhanced operation.

In many cases, you can use a system as both a driving system and a target system. However, you can make a separate IPL-able clone of the running system to use as a target system. The clone must include copies of all system libraries that SMP/E updates, copies of the SMP/E CSI data sets that describe the system libraries, and your PARMLIB and PROCLIB.

Use separate driving and target systems in the following situations:

- When you install a new level of a product that is already installed, the new level of the product will replace the old one. By installing the new level onto a separate target system, you can test the new level and keep the old one in production at the same time.
- When you install a product that shares libraries or load modules with other products, the installation can disrupt the other products. By installing the product onto a separate target system, you can assess these impacts without disrupting your production system.

---

### 5.1 Driving System Requirements

This section describes the environment of the driving system required to install MQ Managed File Transfer.

#### 5.1.1 Machine Requirements

The driving system can run in any hardware environment that supports the required software.

### 5.2.1 Machine Requirements

The target system can run in any hardware environment that supports the required software.

### 5.2.2 Programming Requirements

**5.2.2.1 Installation Requisites:** Installation requisites identify products that are required and *must* be present on the system or products that are not required but *should* be present on the system for the successful installation of this product.

Mandatory installation requisites identify products that are required on the system for the successful installation of this product. These products are specified as PREs or REQs.

Conditional installation requisites identify products that are *not* required for successful installation of this product but can resolve such things as certain warning messages at installation time. These products are specified as IF REQs.

**5.2.2.2 Operational Requisites:** Operational requisites are products that are required and *must* be present on the system or products that are not required but *should* be present on the system for this product to operate all or part of its functions.

Mandatory operational requisites identify products that are required for this product to operate its basic functions. These products are specified as PREs or REQs.

Conditional operational requisites identify products that are *not* required for this product to operate its basic functions but are required at run time for this product to operate specific functions. These products are specified as IF REQs.

MQ Managed File Transfer has no conditional operational requisites.

The recommended way of running MQ Managed File Transfer is by using the JZOS launcher "The JZOS functionality now included in IBM SDK for z/OS, Java Technology Edition (and other z/OS Java products) consists of batch launcher capabilities, system services, and file I/O capabilities."

**5.2.2.3 Toleration/Coexistence Requisites:** Toleration/coexistence requisites identify products that must be present on sharing systems. These systems can be other systems in a multisystem environment (not necessarily sysplex), a shared DASD environment (such as test and production), or systems that reuse the same DASD environment at different time intervals.

MQ Managed File Transfer has no toleration/coexistence requisites.

**5.2.2.4 Incompatibility (Negative) Requisites:** Negative requisites identify products that must *not* be installed on the same system as this product.

### 5.2.3 DASD Storage Requirements

MQ Managed File Transfer libraries can reside on all supported DASD types.

1. For non-RECFM U data sets, IBM recommends using system-determined block sizes for efficient DASD utilization. For RECFM U data sets, IBM recommends using a block size of 32760, which is most efficient from the performance and DASD utilization perspective.
2. Abbreviations used for data set types are shown as follows.

- U** Unique data set, allocated by this product and used by only this product. This table provides all the required information to determine the correct storage for this data set. You do not need to refer to other tables or program directories for the data set size.
- S** Shared data set, allocated by this product and used by this product and other products. To determine the correct storage needed for this data set, add the storage size given in this table to those given in other tables (perhaps in other program directories). If the data set already exists, it must have enough free space to accommodate the storage size given in this table.
- E** Existing shared data set, used by this product and other products. This data set is *not* allocated by this product. To determine the correct storage for this data set, add the storage size given in this table to those given in other tables (perhaps in other program directories). If you currently have a previous release of this product installed in these libraries, the installation of this release will delete the old release and reclaim the space that was used by the old release and any service that had been installed. You can determine whether these libraries have enough space by deleting the old release with a dummy function, compressing the libraries, and comparing the space requirements with the free space in the libraries.

3. Abbreviations used for the file system path type are as follows.

- N** New path, created by this product.

4. All target and distribution libraries listed have the following attributes:

- The default name of the data set can be changed.
- The default block size of the data set can be changed.
- The data set can be merged with another data set that has equivalent characteristics.
- The data set can be either a PDS or a PDSE.

5. All target libraries listed have the following attributes:

- These data sets can be SMS-managed, but they are not required to be SMS-managed.
- These data sets are not required to reside on the IPL volume.
- The values in the "Member Type" column are not necessarily the actual SMP/E element types that are identified in the SMPMCS.

6. All target libraries that are listed and contain load modules have the following attributes:

- These data sets can be in the LPA, but they are not required to be in the LPA.
- These data sets can be in the LNKLIST.
- These data sets are not required to be APF-authorized.

The following figures list data sets that are not used by SMP/E, but are required for MQ Managed File Transfer to run.

### 5.3 FMIDs Deleted

Installing MQ Managed File Transfer might result in the deletion of other FMIDs. To see which FMIDs will be deleted, examine the ++VER statement in the SMPMCS of the product.

If you do not want to delete these FMIDs at this time, install MQ Managed File Transfer into separate SMP/E target and distribution zones.

**Note:** These FMIDs are not automatically deleted from the Global Zone. If you want to delete these FMIDs from the Global Zone, use the SMP/E REJECT NOFMID DELETEFMID command. See the SMP/E Commands book for details.

### 5.4 Special Considerations

MQ Managed File Transfer has no special considerations for the target system.

---

## 6.0 Installation Instructions

This chapter describes the installation method and the step-by-step procedures to install and to activate the functions of MQ Managed File Transfer.

Please note the following points:

- If you want to install MQ Managed File Transfer into its own SMP/E environment, consult the SMP/E manuals for instructions on creating and initializing the SMPCSI and the SMP/E control data sets.
- You can use the sample jobs that are provided to perform part or all of the installation tasks. The SMP/E jobs assume that all DDDEF entries that are required for SMP/E execution have been defined in appropriate zones.
- You can use the SMP/E dialogs instead of the sample jobs to accomplish the SMP/E installation steps.

---

### 6.1 Installing MQ Managed File Transfer

#### 6.1.1 SMP/E Considerations for Installing MQ Managed File Transfer

Use the SMP/E RECEIVE, APPLY, and ACCEPT commands to install this release of MQ Managed File Transfer.

#### 6.1.2 SMP/E Options Subentry Values

The recommended values for certain SMP/E CSI subentries are shown in Figure 16. Using values lower than the recommended values can result in failures in the installation. DSSPACE is a subentry in the GLOBAL options entry. PEMAX is a subentry of the GENERAL entry in the GLOBAL options entry. See the SMP/E manuals for instructions on updating the global zone.

### 6.1.3 Sample Jobs

The following sample installation jobs are provided as part of the product to help you install MQ Managed File Transfer:

The sample installation jobs are sorted by name into an order in which to run them in sequence (after editing) to install MQ Managed File Transfer. The exact order in which to run the jobs is not absolutely critical. Running the jobs in either the sequence they are listed in the list below or in the text of this chapter is acceptable.

Appendix B, “Automated Customization of Installation JCL” on page 29 highlights an automated way to customize the installation of MQ Managed File Transfer.

You can access the sample installation jobs by performing an SMP/E RECEIVE (refer to 6.1.9, “Perform SMP/E RECEIVE” on page 22) then copy the jobs from the RELFILES to a work data set for editing and submission. See Figure 17 to find the appropriate relfile data set.

You can also copy the sample installation jobs from the tape or product files by submitting the following job. Depending on your distribution medium, use either the //TAPEIN or the //FILEIN DD statement and comment out or delete the other statement. Before you submit the job, add a JOB statement and change the lowercase parameters to uppercase values to meet the requirements of your site.

See the following information to update the statements in the previous sample:

**TAPEIN:**

- tunit** is the unit value that matches the product package.
  - volser** is the volume serial that matches the product package.
  - x** is the tape file number that indicates the location of the data set name on the tape.
- See the documentation that is provided by CBPDO for the location of IBM.HMF9901.F1 on the tape.

**FILEIN:**

- filevol** is the volume serial of the DASD device where the downloaded files reside.

**OUT:**

- jcl-library-name** is the name of the output data set where the sample jobs are stored.
- dasdvol** is the volume serial of the DASD device where the output data set resides.

**SYSIN:**

- xxxxIN** is either TAPEIN or FILEIN depending on your input DD statement.

Customize each of the sample jobs listed in Figure 17 on page 18. Each sample job contains comments with specific instructions for customization.

## 6.1.4 Prepare the installation environment

**6.1.4.1 Global zone:** If you are installing into an existing global zone, check that:

- The PEMAX option entry is set to 9999, or left to default.
- The DSSPACE options entry specifies at least 800 directory blocks.

If you are installing into a new global zone, edit and submit sample job BFGGBLZ to create a new SMP/E global zone for MQ Managed File Transfer. Ensure that the JOB statement is valid for your system. Consult the instructions in the sample job for more information.

**Expected Return Codes and Messages:** BFGGBLZ has a number of steps, all of which should complete with a return code of 0.

If any of the return codes is not 0, inspect the job output to determine what caused the problem and correct it, then rerun the job from the step that failed.

**6.1.4.2 Target and distribution zones:** If you need to create new target and distribution zones for MQ Managed File Transfer, edit and submit the following sample jobs:

- BFGCTGTZ to create a new target zone.
- BFGDDISZ to create a new distribution zone.

Ensure in each case that the JOB statement is valid for your system. Consult the instructions in the sample job for more information.

**Expected Return Codes and Messages: 0**

Both jobs consist of a number of steps, all of which should complete with a return code of 0.

If any of the return codes is not 0, inspect the job output to determine what caused the problem, correct it, and then rerun the job from the step that failed.

## **6.1.5 Allocate SMP/E Target and Distribution Libraries**

Edit and submit sample job BFGEALOC to allocate the SMP/E target and distribution libraries for MQ Managed File Transfer. Consult the instructions in the sample job for more information.

Make sure the data sets are allocated on the required volumes.

**Expected Return Codes and Messages:**

You will receive a return code of 0 if this job runs correctly.

## **6.1.6 Allocate, create and mount ZFS Files**

This job allocates, creates a mountpoint, and mounts zFS data sets.

If you plan to install MQ Managed File Transfer into a new z/OS UNIX file system, you can edit and submit the optional BFGFAZFS job to perform the following tasks:

- Create the z/OS UNIX file system
- Create a mountpoint
- Mount the z/OS UNIX file system on the mountpoint

Consult the instructions in the sample job for more information.

The recommended z/OS UNIX file system type is *zFS*. The recommended mountpoint is */usr/lpp/mqmft/V9R0Mx*.

Before running the sample job to create the z/OS UNIX file system, you must ensure that OMVS is active on the driving system. zFS must be active on the driving system if you are installing MQ Managed File Transfer into a file system that is zFS.

If you create a new file system for this product, consider updating the BPXPRMxx PARMLIB member to mount the new file system at IPL time. This action can be helpful if an IPL occurs before the installation is completed.

See the following information to update the statements in the previous sample:

**#dsn** is the name of the data set holding the z/OS UNIX file system.  
**/usr/lpp/mqmfte/V9R0Mx** is the name of the mountpoint where the z/OS UNIX file system will be mounted.

#### **Expected Return Codes and Messages:**

You will receive a return code of 0 if this job runs correctly.

### **6.1.7 Allocate File System Paths**

The target system file system data set must be mounted on the driving system when running the sample BFGGMKEX job since the job will create paths in the zFS.

Before running the sample job to create the paths in the file system, you must ensure that OMVS is active on the driving system and that the target system's file system is mounted to the driving system. zFS must be active on the driving system if you are installing MQ Managed File Transfer into a file system that is zFS.

If you plan to install MQ Managed File Transfer into a new file system, you must create the mountpoint and mount the new file system to the driving system for MQ Managed File Transfer.

The recommended mountpoint is */usr/lpp/mqmfte/V9R0Mx*.

Edit and submit sample job BFGGMKEX to allocate the file system paths for MQ Managed File Transfer. Consult the instructions in the sample job for more information.

If you create a new file system for this product, consider updating the BPXPRMxx PARMLIB member to mount the new file system at IPL time. This action can be helpful if an IPL occurs before the installation is completed.

#### **Expected Return Codes and Messages:**

You will receive a return code of 0 if this job runs correctly.

## 6.1.8 Create DDDEF Entries

Edit and submit sample job BFGHDDEF to create DDDEF entries for the SMP/E target and distribution data sets and directories for MQ Managed File Transfer. Make sure the call library DDDEFs point to the corresponding data sets for your z/OS target system. Consult the instructions in the sample job for more information.

Check the job output to verify that all directories have been created.

**Expected Return Codes and Messages:** You will receive a return code of 0 if this job runs correctly.

## 6.1.9 Perform SMP/E RECEIVE

If you have obtained MQ Managed File Transfer as part of a CBPDO, use the RCVPDO job in the CBPDO RIMLIB data set to receive the MQ Managed File Transfer FMIDs, service, and HOLDDATA that are included on the CBPDO package. For more information, see the documentation that is included in the CBPDO.

You can also choose to edit and submit sample job BFGIRECV to perform the SMP/E RECEIVE for MQ Managed File Transfer. Consult the instructions in the sample job for more information.

**Expected Return Codes and Messages:** You will receive a return code of 0 if this job runs correctly.

## 6.1.10 Perform SMP/E APPLY

1. Ensure that you have the latest HOLDDATA; then edit and submit sample job BFGJAPLY to perform an SMP/E APPLY CHECK for MQ Managed File Transfer. Consult the instructions in the sample job for more information.

The latest HOLDDATA is available through several different portals, including <http://service.software.ibm.com/holdata/390holddata.html>. The latest HOLDDATA may identify HIPER and FIXCAT APARs for the FMIDs you will be installing. An APPLY CHECK will help you determine if any HIPER or FIXCAT APARs are applicable to the FMIDs you are installing. If there are any applicable HIPER or FIXCAT APARs, the APPLY CHECK will also identify fixing PTFs that will resolve the APARs, if a fixing PTF is available.

You should install the FMIDs regardless of the status of unresolved HIPER or FIXCAT APARs. However, do not deploy the software until the unresolved HIPER and FIXCAT APARs have been analyzed to determine their applicability. That is, before deploying the software either ensure fixing PTFs are applied to resolve all HIPER or FIXCAT APARs, or ensure the problems reported by all HIPER or FIXCAT APARs are not applicable to your environment.

To receive the full benefit of the SMP/E Causer SYSMOD Summary Report, do *not* bypass the PRE, ID, REQ, and IFREQ on the APPLY CHECK. The SMP/E root cause analysis identifies the cause only of *errors* and not of *warnings* (SMP/E treats bypassed PRE, ID, REQ, and IFREQ conditions as warnings, instead of errors).

Here are sample APPLY commands:

- a. To ensure that all recommended and critical service is installed with the FMIDs, receive the latest HOLDDATA and use the APPLY CHECK command as follows

```
APPLY S(fmid,fmid,...) CHECK
FORFMID(fmid,fmid,...)
SOURCEID(RSU*)
FIXCAT(IBM.ProductInstall-RequiredService)
GROUPEXTEND .
```

Some HIPER APARs might not have fixing PTFs available yet. You should analyze the symptom flags for the unresolved HIPER APARs to determine if the reported problem is applicable to your environment and if you should bypass the specific ERROR HOLDS in order to continue the installation of the FMIDs.

This method requires more initial research, but can provide resolution for all HIPERs that have fixing PTFs available and are not in a PE chain. Unresolved PEs or HIPERs might still exist and require the use of BYPASS.

- b. To install the FMIDs without regard for unresolved HIPER APARs, you can add the BYPASS(HOLDCLASS(HIPER)) operand to the APPLY CHECK command. This will allow you to install FMIDs even though one or more unresolved HIPER APARs exist. After the FMIDs are installed, use the SMP/E REPORT ERRSYSMODS command to identify unresolved HIPER APARs and any fixing PTFs.

This method is quicker, but requires subsequent review of the Exception SYSMOD report produced by the REPORT ERRSYSMODS command to investigate any unresolved HIPERs. If you have received the latest HOLDDATA, you can also choose to use the REPORT MISSINGFIX command and specify Fix Category IBM.ProductInstall-RequiredService to investigate missing recommended service.

If you bypass HOLDS during the installation of the FMIDs because fixing PTFs are not yet available, you can be notified when the fixing PTFs are available by using the APAR Status Tracking (AST) function of ServiceLink or the APAR Tracking function of ResourceLink.

2. After you take actions that are indicated by the APPLY CHECK, remove the CHECK operand and run the job again to perform the APPLY.

**Note:** The GROUPEXTEND operand indicates that SMP/E applies all requisite SYSMODs. The requisite SYSMODS might be applicable to other functions.

**Expected Return Codes and Messages from APPLY CHECK:** You will receive a return code of 0 if this job runs correctly.

**Expected Return Codes and Messages from APPLY:** You will receive a return code of 0 if this job runs correctly.

### 6.1.11 Perform SMP/E ACCEPT

Edit and submit sample job BFGKACPT to perform an SMP/E ACCEPT CHECK for MQ Managed File Transfer. Consult the instructions in the sample job for more information.

To receive the full benefit of the SMP/E Causer SYSMOD Summary Report, do *not* bypass the PRE, ID, REQ, and IFREQ on the ACCEPT CHECK. The SMP/E root cause analysis identifies the cause of *errors* but not *warnings* (SMP/E treats bypassed PRE, ID, REQ, and IFREQ conditions as warnings rather than errors).

Before you use SMP/E to load new distribution libraries, it is recommended that you set the ACCJCLIN indicator in the distribution zone. In this way, you can save the entries that are produced from JCLIN in the distribution zone whenever a SYSMOD that contains inline JCLIN is accepted. For more information about the ACCJCLIN indicator, see the description of inline JCLIN in the SMP/E Commands book for details.

After you take actions that are indicated by the ACCEPT CHECK, remove the CHECK operand and run the job again to perform the ACCEPT.

**Note:** The GROUPEXTEND operand indicates that SMP/E accepts all requisite SYSMODs. The requisite SYSMODS might be applicable to other functions.

**Expected Return Codes and Messages from ACCEPT CHECK:** You will receive a return code of 0 if this job runs correctly.

If PTFs that contain replacement modules are accepted, SMP/E ACCEPT processing will link-edit or bind the modules into the distribution libraries. During this processing, the Linkage Editor or Binder might issue messages that indicate unresolved external references, which will result in a return code of 4 during the ACCEPT phase. You can ignore these messages, because the distribution libraries are not executable and the unresolved external references do not affect the executable system libraries.

**Expected Return Codes and Messages from ACCEPT:** You will receive a return code of 0 if this job runs correctly.

### 6.1.12 Run REPORT CROSSZONE

The SMP/E REPORT CROSSZONE command identifies requisites for products that are installed in separate zones. This command also creates APPLY and ACCEPT commands in the SMPPUNCH data set. You can use the APPLY and ACCEPT commands to install those cross-zone requisites that the SMP/E REPORT CROSSZONE command identifies.

After you install MQ Managed File Transfer, it is recommended that you run REPORT CROSSZONE against the new or updated target and distribution zones. REPORT CROSSZONE requires a global zone with ZONEINDEX entries that describe all the target and distribution libraries to be reported on.

For more information about REPORT CROSSZONE, see the SMP/E manuals.

### 6.1.13 Cleaning Up Obsolete Data Sets, Paths, and DDDEFs

The following data sets, which were allocated and used by previous releases of this product, are no longer used in this release. You can delete these obsolete data sets after you delete the previous release from your system.

## 6.2 Activating MQ Managed File Transfer

### 6.2.1 File System Execution

If you mount the file system in which you have installed MQ Managed File Transfer in read-only mode during execution, then you do not have to take further actions to activate MQ Managed File Transfer.

If you have included a mount statement in BPXPRMxx PARMLIB member for this file system, ensure it includes the operand MODE(READ).

To change the file system to read only in Unix System Services, execute the following USS commands:

1. `umount -o immediate pathname`
2. `mount -t zfs -d destsys -f fsname -r pathname`

For a detailed explanation of the above commands, refer to the z/OS UNIX System Services Command Reference, listed in Figure 3 on page 4.

You have now installed IBM MQ Managed File Transfer for z/OS. Before you can start to use IBM MQ Managed File Transfer for z/OS, it must be customized. This is described in the Configuring section of the IBM MQ Managed File Transfer for z/OS product documentation in IBM Knowledge Center.

## **Appendix B. Automated Customization of Installation JCL**

Automated customization of installation JCL makes tailoring each piece of JCL individually unnecessary, reducing the chances of making a mistake.

Edit BFGASYSJ and follow the instructions in the job to define the values you want to use to tailor the installation JCL. The figures in Appendix C, “High-Level Qualifiers and Symbolic Parameters” on page 31 show the values you must tailor and have space for you to record your choices.

Submit BFGASYSJ. Expected return code 0.

A return code of 4 means that the JCL has been automatically updated, but there may be some JCL jobs which could not be updated correctly. The job output from the automatic update job will indicate which members may require further manual updates to run correctly.
